THE AUDIT COMMITTEE WILL ALSO REVIEW THE RECOMMENDATIONS PUT FORTH IN THE MANAGEMENT LETTER AS WELL AS ANY WHISTLEBLOWER OR CONFLICT OF INTEREST COMMUNICATION WITH APPROPRIATE LEADERSHIP, MANAGEMENT AND/OR AUDITORS.
