Consent By Use

By using the Site, you consent to our using any information that you provide to us or that we collect, in accordance with the Terms and of this Policy. If you do not agree to this Policy and the Terms, do not use this Site.

Modification

We reserve the right to revise or make any changes to the Policy from time to time in order to deal with new issues or changes on the Site or in the law. Your use of the Site after any changes to this Policy means that you accept such changes. Please review this page periodically to be familiar with the most current version of the Policy. Information We Collect and Track

JCRC-NY collects and retains two types of information about Site visitors: (i) personal information that individual visitors provide when interacting on the Site, or voluntarily provide via forms or in emails; and (ii) tracking data, which is automatically collected from every Site visitor, (collectively, "Information"). The Information that we gather may include your name, title and address ("Postal Information"), telephone number, email address or other elements of personal information. Also if you contact us, we may keep a record of your correspondence and any Information.

You may decline to provide any personal information, but please understand that you might be unable to register on JCRC-NY's Site or to participate in activities or services offered by JCRC-NY on the Site.

The tracking data we record includes such information as the number and frequency of visits to the Site, the websites that you access before and after you visit the Site, the Internet software used to access the Site, and your IP address and Internet service provider.

How We Use Your Information

The Information that you provide to us is used for our business purposes and the purpose for which you provided it. JCRC-NY may also use the Information to contact you about the Site or to request your input regarding ways in which we might improve the Site. We may also use your Information to inform you about JCRC-NY's activities, services, events and fundraising efforts in which JCRC-NY hopes you may be interested. The Information may also be analyzed so that we can provide you with useful information and serve you better through enhanced features and functions on the Site.

We will not disclose any personal information to third parties, except (i) to parties who perform a service for us, such as sending you mail or email or web hosting; (ii) when we believe that such disclosure is required by law; (iii) to enforce this Policy or the Terms; (iv) to protect the rights, property, security or safety of JCRC-NY, Site users or the public; (v) to respond to an emergency; or (vi) as otherwise stated in this Policy. We may disclose Information to certain third parties, if you have requested or authorized the disclosure of such Information. The Information provided to third parties is limited to the Information needed to perform their functions. We seek to limit third-party use of Information; however, we are not responsible for such third-party use of Information that is not in compliance with this Policy.

JCRC-NY may make your Postal Information available to other, pre-screened, reputable not-for-profit organizations. This information is never sold, and if you would like to opt out of having JCRC-NY share your name, title and address with other not-for-profit organizations, please email eisenbergm@jcrny.org with "Opt Out" in the subject line.

JCRC-NY may use certain tracking data for a variety of purposes such as: compiling statistical, demographic or aggregated information about visitors to the Site; for load balancing metrics; and creating reports on user demographics and traffic patterns.

Use of Cookies

We use cookies to enhance your experience on the Site. "Cookies" are small pieces of information that a website transfers to your computer's hard drive for record-keeping purposes. The use of cookies makes web surfing easier by performing certain functions such as saving your passwords and your personal preferences in connection with your use of a particular website. Many consider the use of cookies to be an industry standard. Your browser is probably set to accept cookies, but you are always free to decline our cookies if your browser permits. If you choose to have your browser refuse cookies, it is possible that some of the Services provided on the Site will not function properly.

Transfer of Information to Third Parties upon a Sale or Change of Control

We retain the right to transfer or assign all Information pursuant to a merger, purchase or other transaction relating to JCRC-NY or our assets, if the assignee or purchaser agrees to abide by the terms of this Policy.

This Policy will be governed by and construed in accordance with the laws of the State of New York, without regard to any principles of conflicts of law. Any action that arises out of or relates to any use of the Site will be filed only in the state or federal courts located in New York County. You hereby consent and submit to the personal jurisdiction of such courts for the purposes of litigating any such action.
